

WAIVER AND RELEASE OF LIABILITY FOR HORSE RIDING

In consideration of Mt. Aetna Camp and Retreat Center and Chesapeake Conference of Seventh-day Adventists (also known as Chesapeake Conference) allows me to ride a horse(s) on the land owned by the Chesapeake Conference or on other lands, I agree as follows.

I fully understand and acknowledge that outdoor recreational activities including the riding of horses have: (a) inherent risks, dangers and hazards and such exists in my use of the land owned by Chesapeake Conference or on other lands; (b) my participation in such activities may result in injury including, but not limited to bodily injury, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owner, employees, officers or agents of Chesapeake Conference; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable causes and such risks, hazards and dangers that are integral to the recreational environment, and integral to the riding of horses; and (d) by participating in these activities, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers or employees of Chesapeake Conference, or by any other person. I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Chesapeake Conference and its owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise, which may arise out of my riding of horses on land owned by Chesapeake Conference, or on other lands. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by Chesapeake Conference and their agents, officers or employees.

The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which Chesapeake Conference or its agents is a party shall be in court of law in Washington County, State of Maryland.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO EXEMPT AND RELIEVE CHESAPEAKE CONFERENCE FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSE BY NEGLIGENCE OR ANY OTHER CAUSES.
